## **Section C. Separation Documentation**

TAX TRANSCRIPT(S) AND W2's: Current year's tax return transcript(s) and W2's.

REFERENCE LETTERS: Please attach two letters from reputable and impartial third party sources who can endorse confirmation of the separation claim. For example, clergy person, marriage counselor, or an

attorney can provide such a letter. The letters should state the date of separation, living arrangements, length

of time they have known student/parent and their knowledge of these events. Please make sure it is legible
